- 5. Electronic Bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/ egp on or before 12:00 Noon on **2081/04/07**. Bid after this deadline shall not be accepted.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2081/04/07at the office of Training Hall, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur. Bids must be valid for a period of 90 of days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 50,000.00 (Fifty Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.
