5. Electronic Bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on **2082/02/09 BS**. Bid after this deadline shall not be accepted.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on **2082/02/09 BS** at the office of **Meeting Hall, Asset Management Department, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur**. Bids must be valid for a period of **90 of days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 5,00,000.00 (Five Lakh Only)**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
