The **Karmachari Sanchaya Kosh (KSK)** invites *electronic* bids from eligible bidders for the procurement of **SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF 4 PCS PASSENGER ESCALATOR FOR KATHMANDU MALL SUNDHARA BUILDING** under National competitive bidding – **Single Stage Single Envelope procedures**.

4. Pre-bid meeting shall be held at Meeting Hall of Asset Management Department, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur, Nepal at **2082/06/29 BS, 1:00 PM**
5. Electronic Bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on **2082/07/12 BS**, Bid after this deadline shall not be accepted.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on **2082/07/12 BS** at the office of **Meeting Hall, Asset Management Department, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 4,30,000.00 (Four Lakhs Thirty Thousand Only)**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
