Bids must be valid for a period of 90 days] from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 21,50,000.00 (Twenty-One Lakhs Fifty Thousand Only) which shall be valid for 30 days beyond the validity period of the bid.
