4. Pre-bid meeting shall be held at Meeting Hall of Asset Management Department, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur, Nepal at **2082/11/27 BS, 1:00 PM**
5. Electronic Bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on **2082/12/09 BS**. Bid after this deadline shall not be accepted.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on **2082/12/09 BS** at the office of **Meeting Hall, Asset Management Department, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security amounting to a minimum of **NRs 50,000/- (In words Fifty Thousand only)**, which shall be valid for **30 days beyond the validity period of the bid**.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
