1. **Employees Provident Fund** invites electronic bids from eligible bidders for the construction of **Maintenance and Rehabilitation Works of the Fire-Damaged Building of the Employees Provident Fund, Hetauda Branch** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 32,583,000.00 (In Words Thirty-Two Million Five Hundred Eighty-Three Thousand only.)**
 - Minimum Work experience of similar size and nature: **Interior Construction Works of Building with a value of at least NRs 8,689,000.00 (In Words Eight Million Six Hundred Eighty-Nine Thousand only.)**
2. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

 6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM on 2026/08/04 (B.S. 2083/04/19)**. Bids received after this deadline will be rejected.
 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 2026/08/04 (B.S. 2083/04/19) at the office of Assets Management Department, Employees Provident Fund, Pulchowk, Lalitpur**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 630,000.00 (Six Hundred Thirty Thousand Only)** which shall be valid for 30 days beyond the validity period of the bid.
 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
